Semester 3 and 4 aim at giving students a high level of proficiency in Private International Law with a focus on International Mobility. This program is a Double degree established by the 2011 convention signed between the University Toulouse Capitole and the University of Dundee in Scotland. Students will thus obtain both a French Master's diploma and the LLM (Latin Legum Magister) under two cumulative conditions: the validation of semester 3 in Toulouse and the mandatory semester 4 in Dundee. The LLM certificate is awarded during a graduation ceremony at the University of Dundee.

LL.M thesis :

The student must write a research thesis in English. The topics will be chosen from a list established by the University of Dundee in association with UT Capitole. This thesis has to be submitted by August according to the examination rules at the University of Dundee (no oral defence is required).

A professional internship is still possible but optional.
